- 1. We are accepting clients who have been exposed to Paraguat and are now suffering from Parkinson's disease and other bad health issues. Scientists knew back in the 1970's that the chemical was bad, and many countries around the world have banned it. Paraquat is a commercial strength herbicide and is sold under various brand names including Paraguat, Paradox, Gramaxone, Parazone among others.
- 2. We are still reviewing cases and accepting clients in our ongoing investigation into panoramic sunroof leaks and resulting interior and electrical damage in certain Volkswagen Golf Sportwagens, Alltracks, Jettas, Tiguans and Atlas SUVs. Litigation has been filed in multiple states.

Emily Roark's Grandmother's Apple Pie

Granny Rahm's Apple Pie

7 to 8 apples (peeled & sliced)
1 cup of sugar
1 Tablespoon of flour
1/8 teaspoon of nutmeg
1/2 teaspoon of cinnamon
Butter
Pie Crust

Mix all the dry ingredients and then mix with peeled apples. Place apples in a pie dish that already has a pie crust placed in it. Dot generously with butter on the top of the apples. Cover with a second crust and seal the two crusts together. Make a few slits in the top crust. Cover the edges of the pie with a pie shield for 25 minutes and bake at 375 degrees. Remove the pie shield and continue to bake at 375 degrees for an additional 25 minutes. Enjoy!
